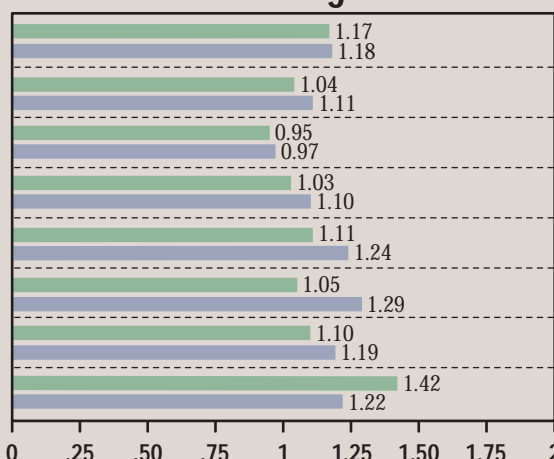

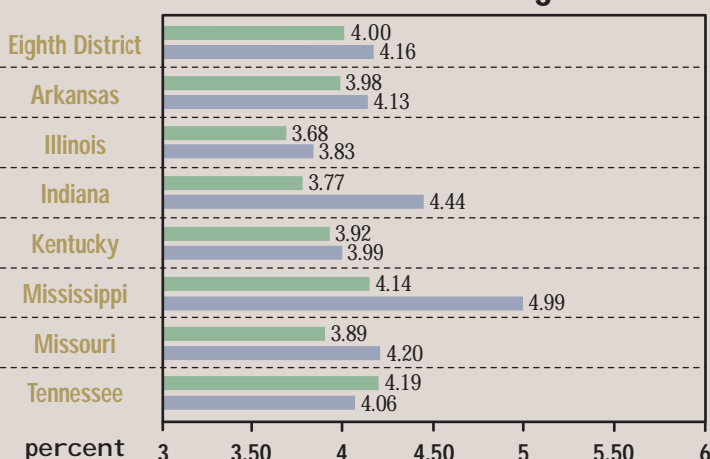

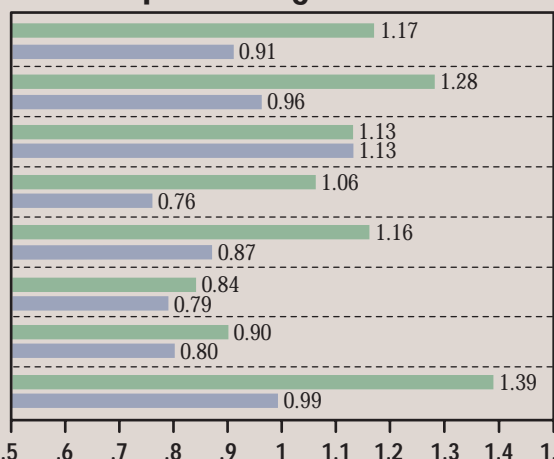
Return on Average Assets *



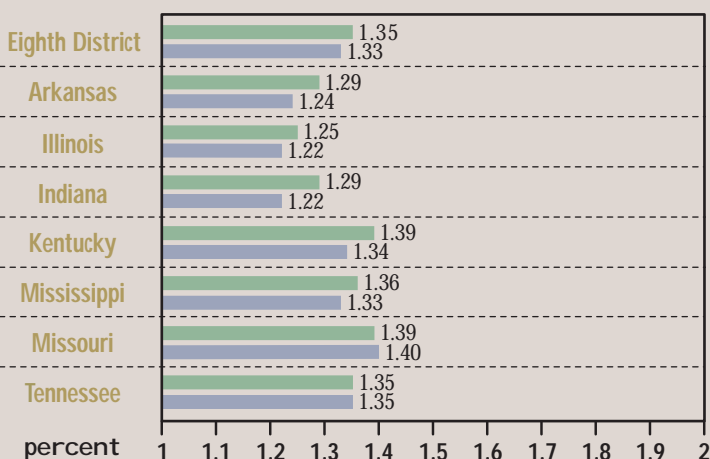
Net Interest Margin*

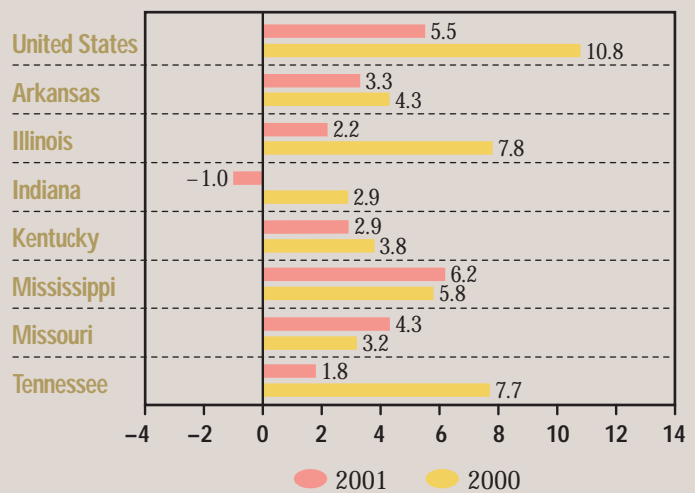

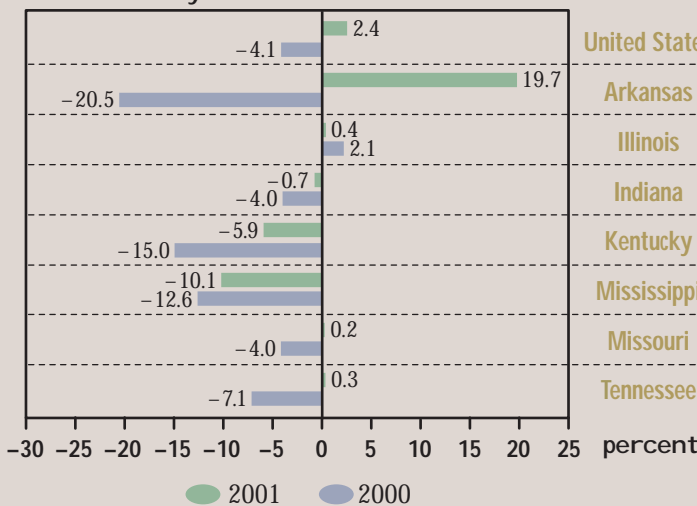

Total Government Revenue Fiscal year-over-fiscal year percent change



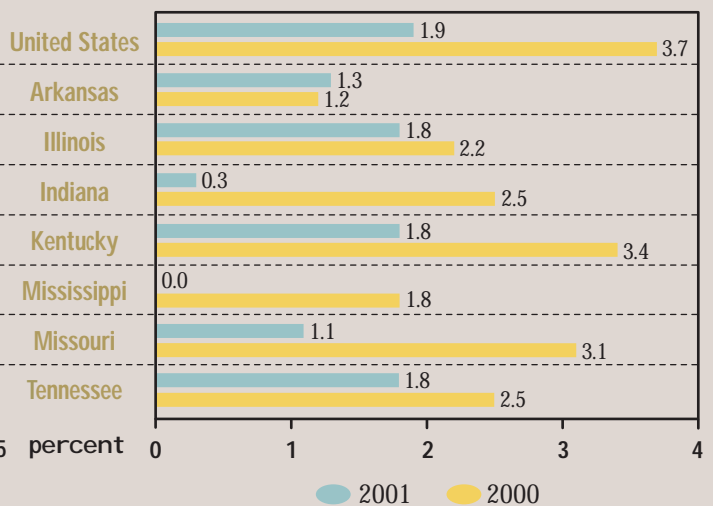

Real Personal Income year-over-year percent change

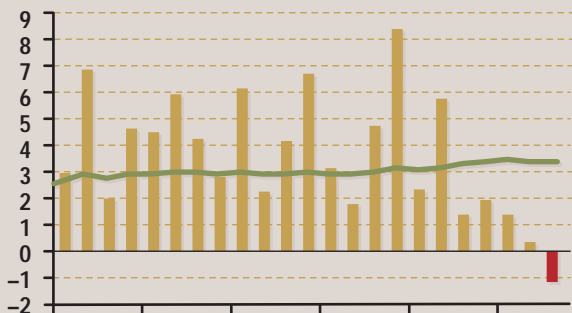

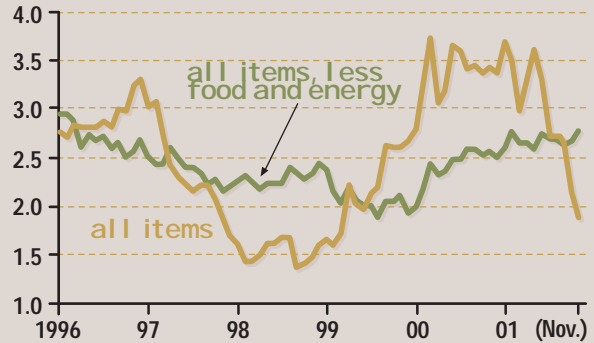

percent

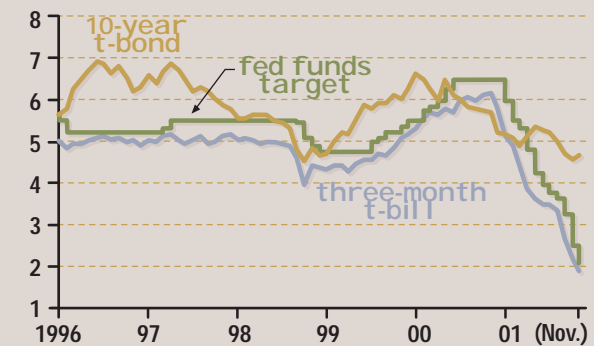

percent



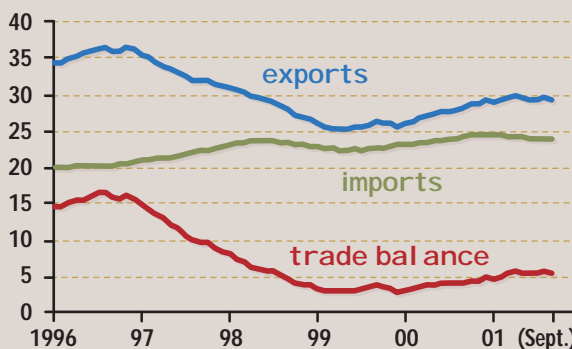
Interest Rates

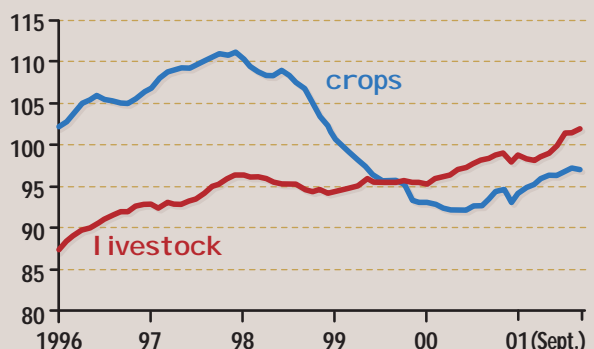
Farm Sector Indicators
