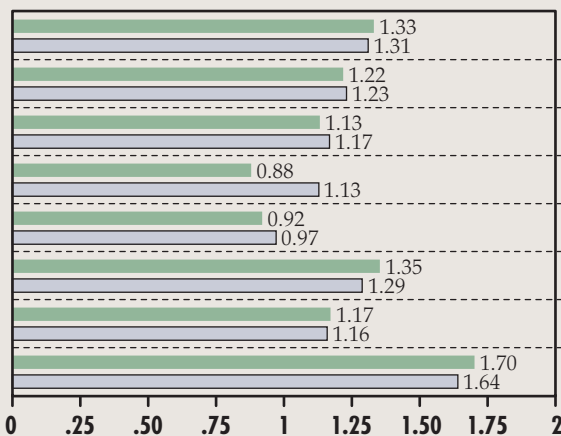

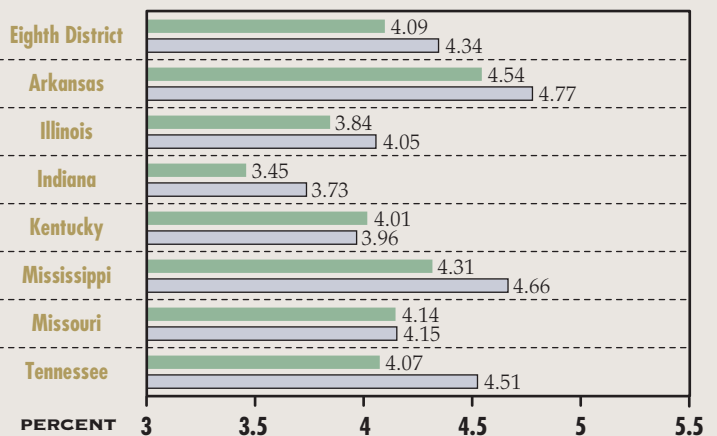

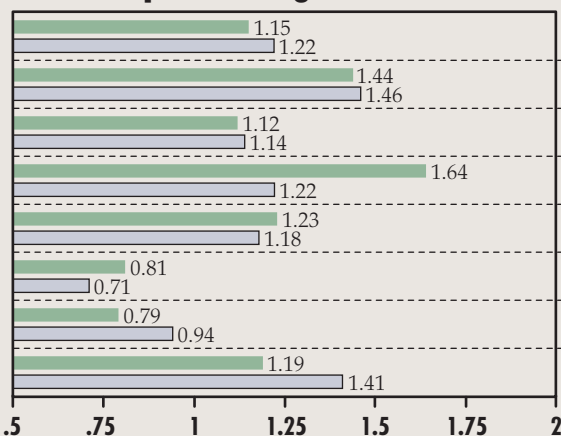
Return on Average Assets*



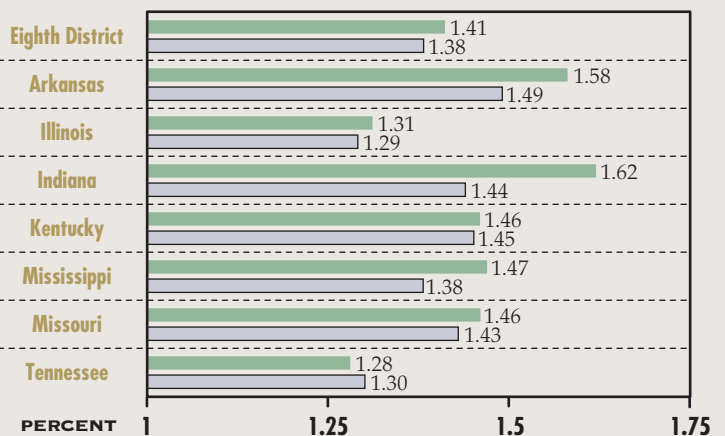
Net Interest Margin*

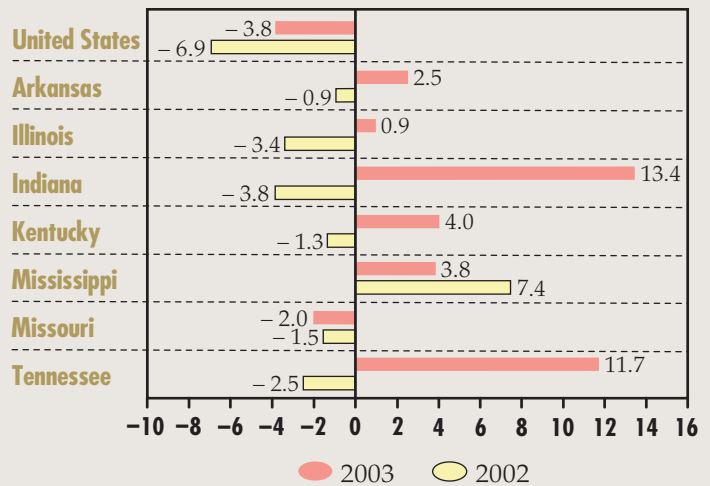

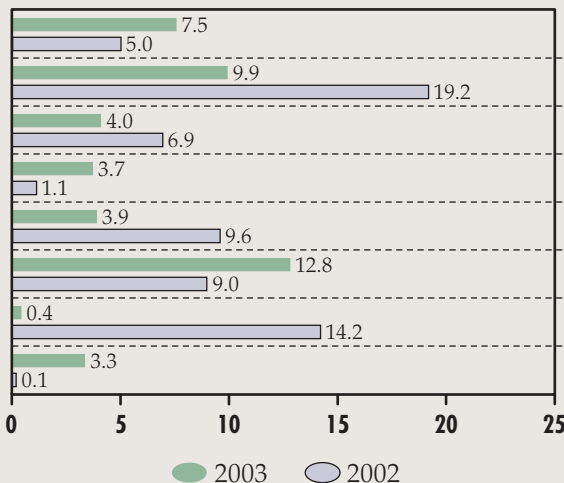

Housing Permits

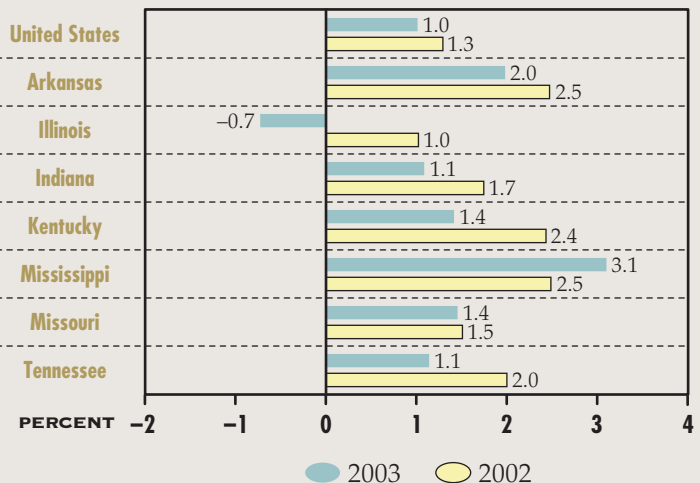
YEAR-OVER-YEAR PERCENT CHANGE IN YEAR-TO-DATE LEVELS

YEAR-OVER-YEAR PERCENT CHANGE

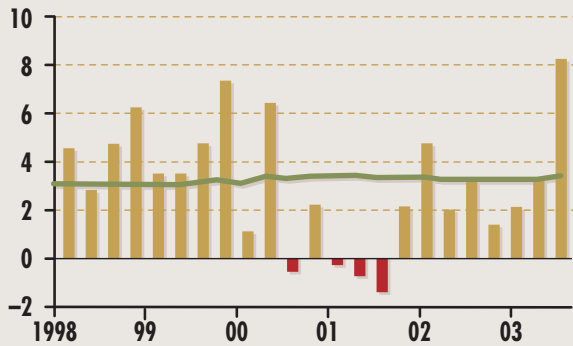

Real GDP Growth

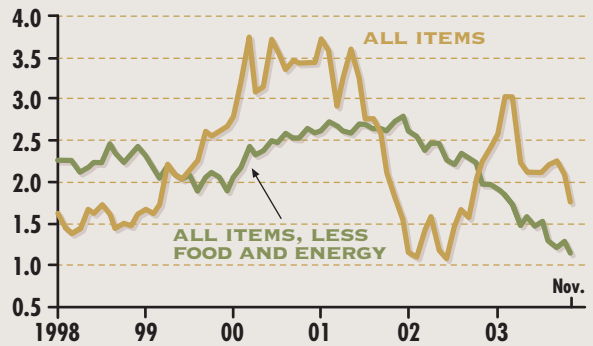

Civilian Unemployment Rate

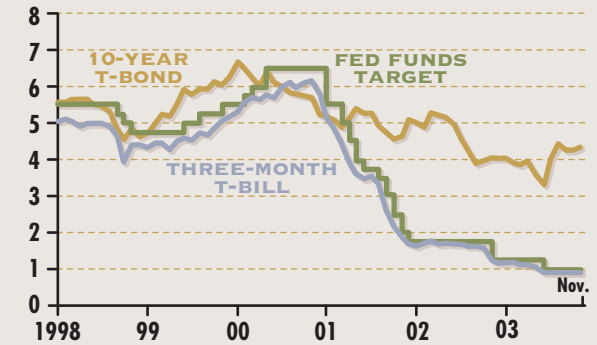

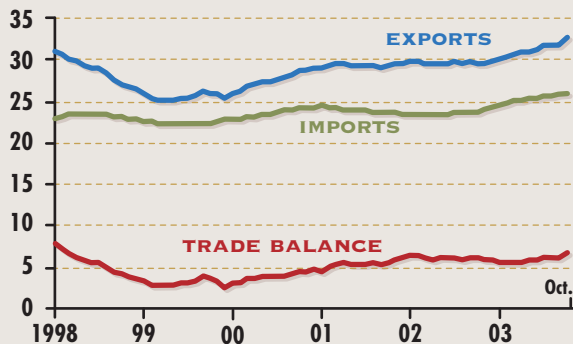

U.S. Agricultural Trade

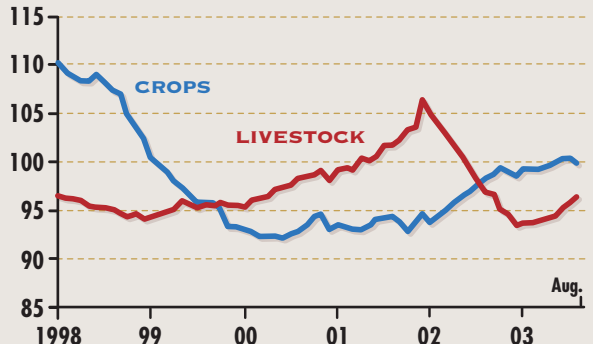
BILLIONS OF DOLLARS
